It involves the following elements of proof: The unauthorized entry; Into a residence or building; Using force, deceit, or property damage; Note that "breaking" a window or a door is not actually necessary to be found guilty of breaking and entering. For instance, deceiving a security guard to gain unauthorized access to an area may be considered breaking and entering.

If there is no such intent, the breaking and entering alone is probably at least illegal trespass, which is a misdemeanor crime.
