### Foundations of Law - Model Penal Code's Mens Rea

The Model Penal Code adjusts the legal causation foreseeability requirement depending on whether the defendant acted purposely, knowingly, recklessly, or negligently. If the defendant's behavior is reckless or negligent, the legal causation foreseeability requirement is analyzed based on the riskof harm, rather than the purposeof the defendant.

The Model Penal Code MPC 2.02 (1) eliminates strict liability for criminal offenses. The only exception is in MPC 2.05, which provides that "violations," but not crimes, can be strict liability offenses. Violations are offenses that cannot result in any punishment besides fines.
