The PNG Constitution did not allow dual citizenship and declared that anyone who was born in PNG and had two indigenous grandparents was automatically a PNG citizen. All four of Mr Ame's grandparents were born in his district in Papua. The High Court unanimously found that Mr Ame ceased to be an Australian citizen on Independence Day.
