The second step in the jurisdictional analysis, the "maritime nexus" test, has developed over the last several decades and is meant to exclude those torts which occur in a maritime locale but which most would agree should not be within the Admiralty Jurisdiction. The "maritime nexus" test now has two parts: 1.

Admiralty Tort Jurisdiction - Cooper and Bilbrey, P.C.

Article III, Section 2 of the United States Constitution grants original jurisdiction to U.S. federal courts over admiralty and maritime matters; however, that jurisdiction is not exclusive, and most maritime cases can be heard in either state or federal courts under the "saving to suitors" clause.
