For tax years beginning after 2015, a qualified small business may elect to claim up to \$250,000 of its credit for increasing research activities as a payroll tax credit against the employer's share of social security tax. On August 8, 2020, the White House issued a Presidential Memorandum on deferring payroll tax obligations in light of the ongoing COVID-19 crisis. The Memorandum directed the Secretary of the Treasury to permit the deferral of the employee portion of Social Security taxes on compensation paid during the four-month period beginning September 1, 2020, and ending December 31, 2020.
