Bar legal definition of bar

Essays are the most common type of written test used by state bar exams. They usually consist of a 2-3 paragraph fact pattern

followed by a call of the question. The topics of the essays depend on the jurisdiction where you'll be taking the test. Each essay can either consist of one area of law or multiple areas of law, often called "crossovers."
