Scots law recognises five main types of security which can be taken over moveable assets: pledge, assignation, lien, hypothec (which is rarely used) and the floating charge. In deciding what security to take, lenders need to consider several factors including the type and location of the asset to be secured and the requirements of each security against the other possible options.

The Law does not apply to moveable assets that require registration in a special register under an existing law (like listed shares, vehicles, ships, aircraft and certain free zone security). Security Registry – The Law requires the registration of mortgages over moveable assets in the Security Registry.
