THE UNFAIR CLAUSES ACCORDING TO THE ITALIAN CIVIL CODE: Italian legal system was one of the first in Europe to adopt rules designed to impose a direct control upon unfair contract terms. These rules, as provided in Articles 1341 and 1342 of the ICC, deal with "general conditions of contract" in particular, which, according to the definition given by Italian Courts, are clauses drawn up for general use (as opposed to clauses specifically designed to individual contracts).
